Joint Action



- Joint Action (HP-JA-2016), 3rd Health Programme and 2016 Work Programme
- 29 nominated partners from 15 EU countries (+ Serbia)
- Participation from Public Health institutions (17), Hospitals (Infectious disease and research departments) (4), NGOs (7) and Universities (1)
- 36 Months (2017-2020)
- Overall budget 2,4 mill Euro (80% EU)

INTEGRATE - Objective

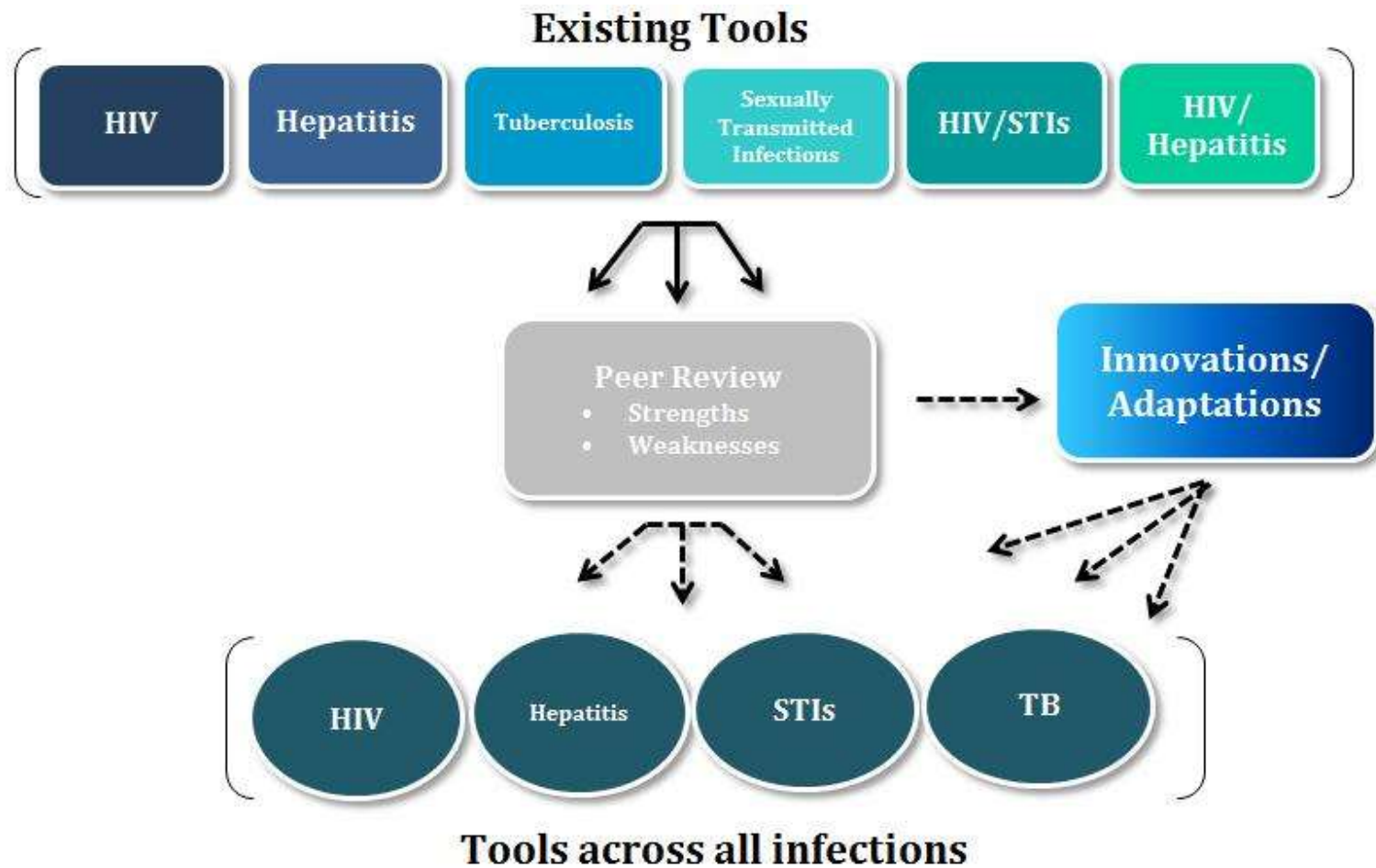
Overall objective:

- Increase integrated early diagnosis and linkage to prevention and care of HIV, viral hepatitis, TB and STIs in EU member states by 2020.
- INTEGRATE builds on a number of previous and current EU-funded projects in which different INTEGRATE partners are also active (Quality Action, OptTEST, EuroHIVEDat, HA-REACT, HEPCARE)

Relevance

- Continued challenges with controlling and preventing further transmission of HIV, Hepatitis, TB and STIs
 - High prevalence of co-infection due to overlaps in key populations and mode of transmission
 - Challenges ensuring that people are diagnosed early and enter the care system
- INTEGRATE supports collaboration between health care institutions, policy institutions and civil society organizations in support to health policy planning development and sustainability.
- Focus on member states in Europe with high rates of HIV, viral hepatitis, TB or STIs and/or low access to care – addressing the relevant gaps depending on the needs and setting in the participating countries.

WP4 - Policy development and sustainability

Objective

- **Sustainability plan** for the Joint Action
- Facilitate the **integration of JA deliverables into national policies, action plans, and/or clinical guidelines** in pilot countries by providing general principles and country-specific recommendation (Roadmap).
- Pilot actions for the **monitoring of patient experience in testing and linkage to care** among people newly diagnosed and living with HIV, hepatitis and/or TB to support potential uptake of best practice and evidence-based policy recommendations.

Main deliverables

- Sustainability plan for the Joint Action
- Report/Roadmap on results of pilot activities
- Patient experience toolkit

WP5 - Integrating testing and linkage to care of HIV, viral hepatitis, TB and STIs

Objective

- **Integration of testing activities targeting HIV, viral hepatitis, TB and STIs and optimise testing of key populations**, including PWID, sex workers and migrants.
- **Expand the use of tools to increase testing and linkage to care** in health care facilities including GPs
- **Support the expansion of HIV home-sampling and home-testing programmes**

Main deliverables

- Innovative and integrated approaches for testing information package.
- Toolkit to increase testing and linkage to care in health care settings. Toolkit to include hepatitis.
- HIV home-sampling and home-testing and linkage to care toolkit.

WP6 – M&E of HIV, viral hepatitis and STIs testing and linkage to care

Objectives

- **Identify indicators to assess the impact of the European Testing Week (ETW)** related to HIV, viral hepatitis and STIs testing and linkage to care.
- Describe methods for **integration of testing and linkage to care data** on HIV, STIs and viral hepatitis from **healthcare settings and community services**.
- To support the **integration of testing and linkage to care data from CBVCT services into national surveillance and monitoring systems**

Main deliverables

- Consensus set of indicators to assess the impact of ETW testing
- Consensus recommendations for collection and integration of CBVCT testing and linkage data in national surveillance systems for HIV, viral hepatitis and STIs

WP7 - use of ICT tools and Partner notification in combination prevention

Objectives

- Improve the **use of ICT tools in combination prevention** by adapting and piloting innovative **information and communication technology programs**.
- **Improve the use of partner notification as a secondary prevention tool**, including descriptions of best practice in data monitoring of “positives” and linkage to care.

Main deliverables

- Review of existing ICT based prevention programs and their effectiveness
- Partner Notification usefulness Technical Report

WP8 - Capacity building

Objectives

- To **identify training needs** and priorities on integration of HIV, viral hepatitis, TB and STIs early diagnosis and linkage to care in the JA partner countries.
- To conduct **3 regional workshops on WP outcomes**.

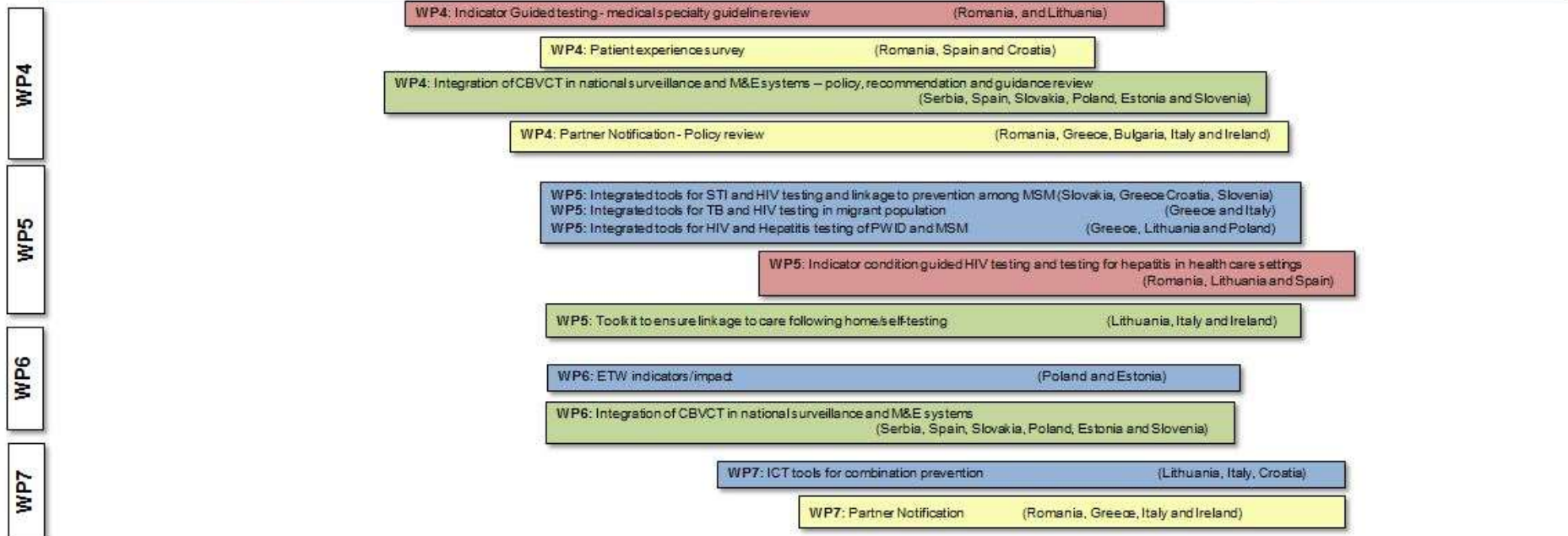
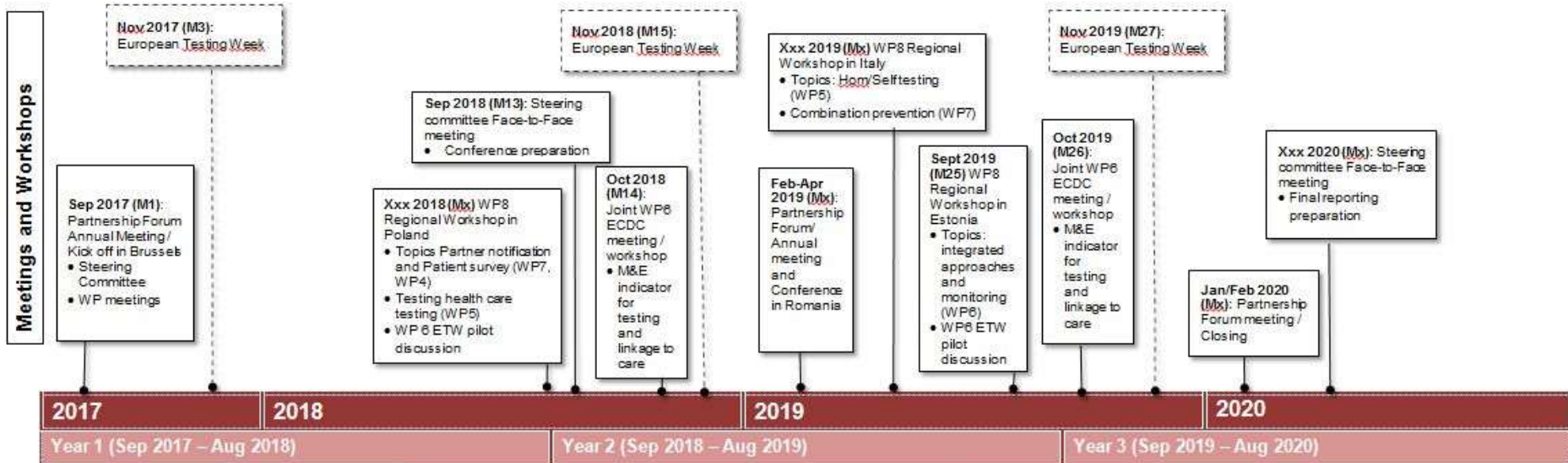
Deliverables
