# WP6- Objectives

## Objectives:

1. To identify indicators and adapt existing data collection/M&E tools (COBATEST) to assess the impact of the European Testing Week (ETW) related to HIV, viral hepatitis and STIs testing and linkage to care.
2. To describe methods and drivers/barriers for integration of testing and linkage to care data on HIV, sexually transmitted infections (STIs) and viral hepatitis from European healthcare settings and community based voluntary counselling and testing (CBVCT) services.
3. To support the integration of testing and linkage to care data from CBVCT services into national surveillance and monitoring and evaluation (M&E) systems on HIV, STIs and hepatitis C virus.

# Objective 1

## Planned activities:

- **Needs assessment for ETW impact evaluation:** Identification of already existing tools and needs for assessing the ETW impact on HIV and HCV for health care settings and CBVCT services
- **Meeting with JA partners to discuss indicators:** Meeting as part of regional workshop with JA partners to reach a consensus on a succinct set of indicators for monitoring and Evaluation of ETW impact
- **Pilot of test of indicators:** Pilot testing consensus set of impact indicators for M&E of ETW impact in HIV, STIs and HCV
- **Final consensus on indicators to monitor and evaluate the ETW impact:** Meeting as part of regional workshop with JA partners to get final consensus on indicators to monitor and evaluate the ETW impact on HIV, STIs and HCV

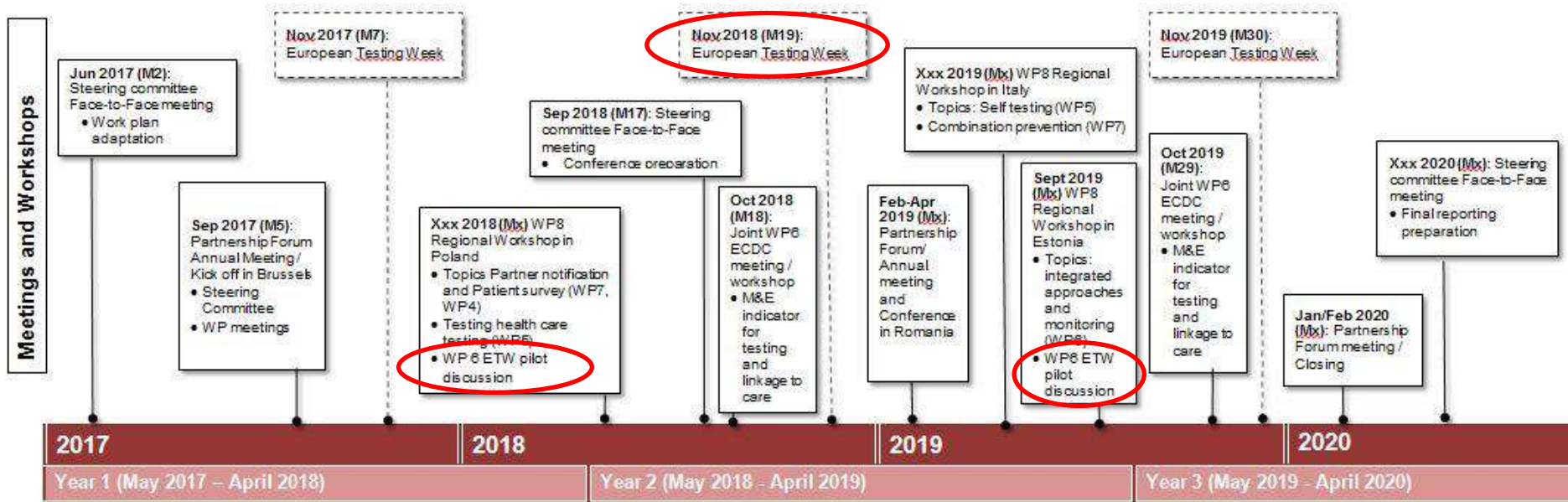

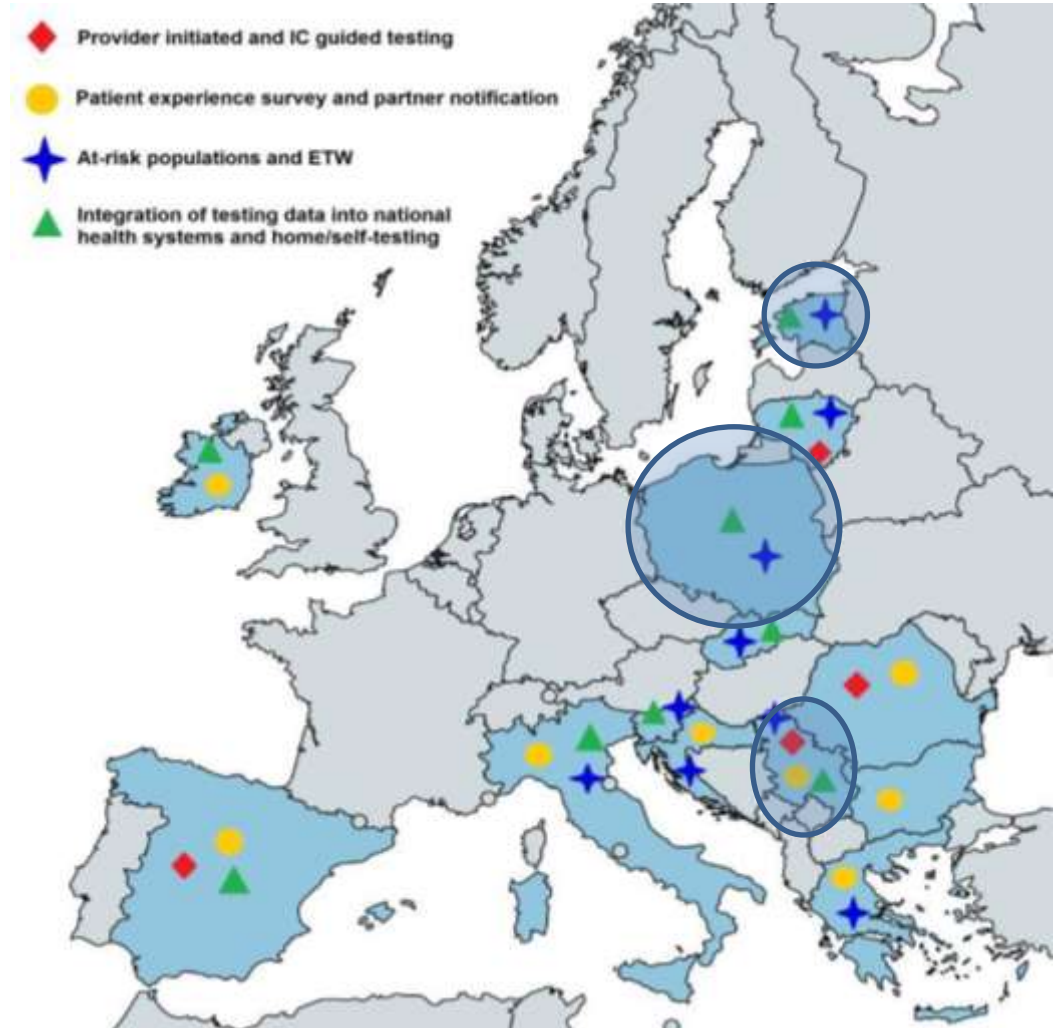

# WP6- Objectives

## Objectives:

# Objectives 2 and 3

## Planned activities:

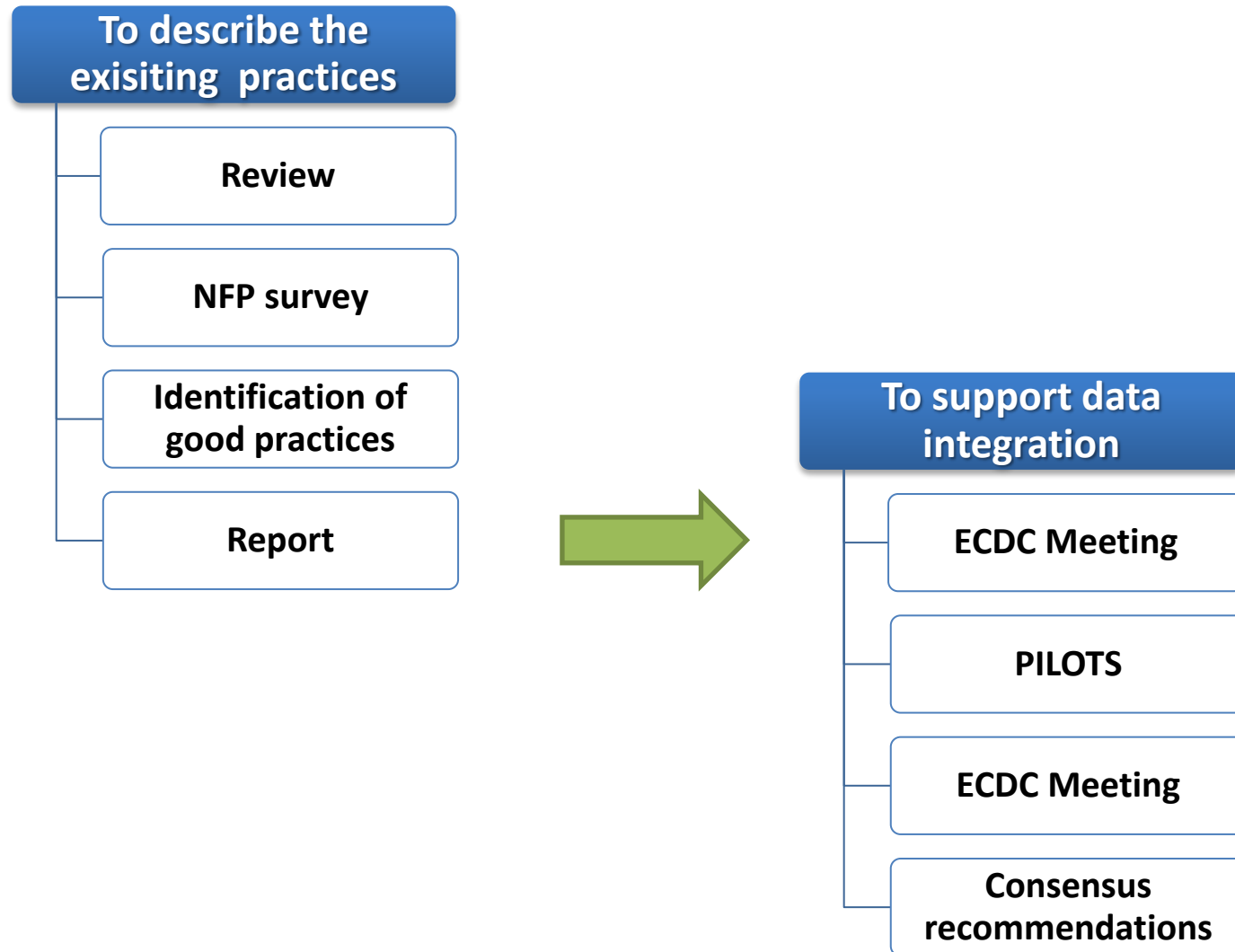
- **Review on current data collection on testing and linkage to care** and integration methods, approaches and processes across Europe on HIV, STIs and viral hepatitis.
- **Survey for NFP** to identify barriers to and facilitators for testing and linkage to care data integration into national surveillance and M&E systems.
- **Identify good practices and examples** from countries and JA partners on approaches and models for HIV testing and linkage to care data collection and integration (from health care and CBVCT services).
- **Report** on current data collection on testing and linkage to care.

# Objectives 2 and 3

## Planned activities:

- **Consensus meeting, in collaboration with the ECDC**, (selected European CBVCT services, national surveillance and M&E systems representatives and the Dublin Declaration WG) to select a set of indicators for the minimum common data collection of testing and linkage to care data to be collected and integrated into national surveillance and M&E systems.
- **Pilot** the set of indicators for minimum common data collection in **CBVCT services** testing for HIV, viral hepatitis and STIs and the integration of this data into national surveillance and M&E systems in 5 countries (Serbia, Spain, Slovakia, Poland, Estonia and Slovenia).
- **Follow-up consensus meeting, in collaboration with the ECDC**, to discuss the outcome of pilots and reach a consensus on key core CBVCT services testing for HIV, viral hepatitis and STIs and linkage to care M&E indicators to be integrated into national surveillance and M&E systems (meeting held in conjunction with WP8 workshop in year 3).

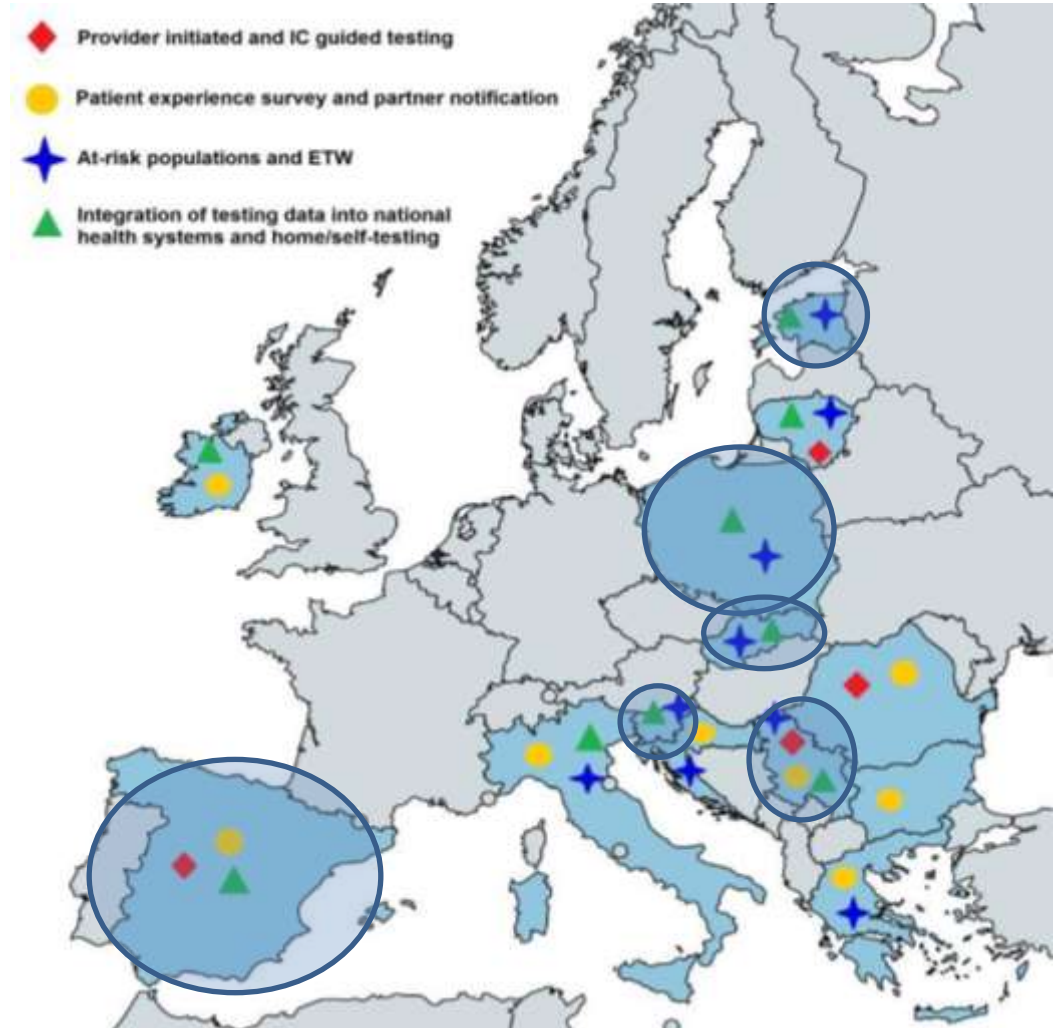
